Elena Koltsaki is a lawyer-mediator based in Greece, a Participating Adjunct Professor at ALBA Graduate Business School at the American College of Greece on Mediation and Negotiations Management and a lead mediation trainer at the Bar of Athens Mediators' Training Institute since 2015, having trained over 2000 mediators worldwide. Elena sits as a member of the International Advisory Board for the Office of the Ombudsman for the United Nations for Funds and Programmes having oversight of the Ombudsman's Global Mediation Panel. She has been recently selected to serve as a Mediation Expert on the implementation of CEPEJ programmes at the Council of Europe European Commission for the Efficiency of Justice. She is the President Elect of the International Academy of Dispute Resolution (INADR – Chicago, USA), and sits as a member of the General Sub-Committee of the International Mediation Institute (IMI) Appraisal Committee (Netherlands) and as member of the Mediation Committee of ICC Hellas. Elena has served as a regular member at the Mediators' Accreditation Committee at the Greek Ministry of Justice and was appointed as a member of the Law Drafting Committee on Mediation, which reformed mediation law in 2018. She is an accredited Civil/Commercial, Family & Workplace Mediator (UK, USA, Greece) with extensive advanced training in mediation, online dispute resolution and negotiations (UK & USA - Harvard Negotiation Institute) and a trained panellist at the Hellenic Ombudsman for Banking Investment Services. She holds a PhD in Law and has long experience in counselling, negotiations and litigation. She has been serving as an Expert Advisor to the Hellenic Parliament and as a dispute resolution expert on international projects with ADR Center – Member of Jams International (Italy). She is ranked in the Who' Who Legal 2020 for Mediation, sits as an International Mediation Expert in ADR Center Global and leads the Mediation Panel at ADR point, the first Greek private ADR Entity notified to the European Commission for Consumer Disputes and registered in the EU ODR platform.
