

BIO – MARINA LUTOVAC

Marina Lutovac je iskusni posrednik i trener za posredovanje.

Gospođa Lutovac je diplomirala na Pravnom fakultetu u Podgorici, Crna Gora, 1980. godine. Završila je obuku za posredovanje 2006. godine i od tada je posrednica u građanskim predmetima, akreditovana od strane Ministarstva pravde Crne Gore. Tokom ovog dugog perioda, gđa Lutovac je prošla niz bazičnih, naprednih i specifičnih obuka o posredovanju u građanskim, porodičnim, privrednim i drugim sporovima.

Od 2019. godine gđa Lutovac je trener za posredovanje. Učestvovala je u velikom broju regionalnih i međunarodnih obuka, konferencija i radionica o pregovorima i pitanjima posredovanja.

Od 2017. godine gđa Lutovac je izvršna direktorka Centra za posredovanje Crne Gore. Članom 11a Zakona o posredovanju (Sl. List 29/12), Vlada Crne Gore je osnovala Centar za posredovanje kao organizaciju, pravno lice. Zakonom se uređuju organi upravljanja Centrom, nadležnosti i načini njihovog izbora, mandat i sredstva za osnivanje i funkcionisanje Centra za posredovanje. Centar za posredovanje osnovan je radi obavljanja stručnih i administrativnih poslova vezanih za posredovanje u građanskim sporovima porodičnopravnim sporovima, privrednim sporovima, radnim sporovima i sporovima vezanim za imovinu fizičkih ili pravnih lica.

Centar za posredovanje radi na sledećim zadacima: predstavlja i štiti interes posrednika, pruža uslove za sprovođenje posredovanja, sprovodi obuke o posredovanju, priprema priručnike, brošure i druge publikacije o posredovanju, organizuje stručne događaje, informiše profesionalnu i širu javnost o posredovanju, čuva dokaze o slučajevima posredovanja, izdaje potvrde o sprovedenim treninzima za posredovanje, donosi Etički kodeks za posrednike i brine se o njegovoj primeni.

Kao direktorka Centra, gđa Lutovac bila je direktno uključena u izradu strateškog i zakonodavnog okvira za dalju promociju i razvoj posredovanja i drugih alternativnih metoda rješavanja sporova u Crnoj Gori. U tom pravcu Vlada Crne Gore usvojila je Program alternativnih metoda rješavanja sporova 2019-2021 i Prijedlog zakona za alternativno rješavanje sporova koji predviđa uvođenje drugih vrsta alternativnih načina rješavanja sporova, uključujući ranu neutralnu evaluaciju, na čiju promociji Centar za medijaciju ulaže puno npora.

Marina Lutovac is experienced mediator and trainer for mediation.

Ms. Lutovac has a degree in Law, graduated at the Law Faculty in Podgorica, Montenegro, in 1980. She completed training for mediation in 2006 and since then she is mediator in civil cases, accredited by the Ministry of Justice of Montenegro. During this long period Ms. Lutovac passed a number of basic, advanced and specific trainings on mediation in civil, family, commercial etc.

Since 2019 Ms. Lutovac is trainer for mediation. She participated in a number of regional and international trainings, conferences and workshops on negotiation and mediation issues.

Since 2017 Ms. Lutovac is Executive Director of the Centre for Mediation of Montenegro. By the article 11a from the Law on Mediation (Official Gazette No 29/12) The Government of Montenegro has established Centre for Mediation as an organisation, legal entity. The Founding Act regulates the governing bodies of the Centre, competencies and methods of their selection, mandate and funds for founding and functioning of the Centre for Mediation. Centre for Mediation is founded for the purpose of conducting professional and administrative work related with mediation in civil disputes-family law disputes, commercial disputes, labour disputes and disputes related to property of physical or legal entities.

Centre for Mediation is working on following tasks: represents and protects the interests of intermediators, provides conditions for the mediation implementation, conducts trainings on mediation, prepares manuals, brochures and other publications on mediation, organises professional events, informs professional and broader audience on mediation, keep the evidence on mediation cases, issue certificates on conducted trainings for mediation, delivers Ethical codex for mediators and takes care on its implementation.

As a Director of the Centre Ms. Lutovac was directly involved in development of the strategic and legislative framework for further promotion and development of mediation and other alternative dispute resolution methods in Montenegro. In that direction Government of Montenegro adopted the Program of alternative methods of dispute resolution 2019-2021 and Proposal law for Alternative Dispute Resolution which foresees introduction of other types of alternative dispute resolution methods, including the Early Neutral Evaluation, on which promotion the Center for Mediation put a lot of efforts.
